A New Year Brings New Alcohol Policy Proposals

The first, 90-day session of the 109th Legislature convened on January 8th, 2025, with 17 new members being sworn in to serve the state of Nebraska. During the first ten days of the session, a number of alcohol-focused bills were introduced. In addition, 2025 brings a new set of legislative rules -- the main one being a limit on the number of bills (20) that each senator can introduce. Senator McKinney attempted to rescind this, but the effort failed earlier this month.

LB 33 (Hunt) seeks to remove 'near beer' from the definition of beer, again. More commonly, 'near beer' is known as non-alcoholic beer, even though these products can contain up to 0.5% alcohol by volume (ABV), smell, and taste like beer. A similar bill was introduced in 2023, however due to strong opposition about it being a gateway to beer containing over 0.5% ABV alcohol for kids who would now be able to legally get a taste for the real



thing and concerns about burdening law enforcement with calls about teens and impaired driving while using this type of product, the bill was soundly defeated.

LB 113 (Quick) increases physical locations a holder of manufacturer's, craft brewery, and micro distillery license can hold from five to ten. This bill also significantly increases (tenfold) how many gallons of product micro distilleries can self-distribute from 500 to 5,000 gallons. This bill would negatively affect the three-tier system of alcohol regulation which protects public health and ensures that taxes are collected.

LB 178 (Clouse) seeks to require all individuals engaged in the sale, service, or mixture of alcoholic products, in providing security, or in verifying customers' ages to have gone through mandatory alcohol server training within 90 days of the start of employment. Some jurisdictions like Lincoln and North Platte already require this in their municipal codes, but this bill would make training mandatory across the state.

LB 186 (Dover) lowers food service requirements within commons areas of entertainment districts to allow alcohol consumption to require that only one of the businesses serve food. The bill also relaxes restrictions regarding these districts in smaller municipalities to permit pedestrians to cross a street or highway while carrying an open alcohol container as long as they are going to another entertainment district licensee.

These four bills have been set for a hearing before the General Affairs committee on Monday, February 3rd at 1:30 p.m. Individuals and organizations wishing to submit public comment on any of these bills simply needs to visit the bill page and click the "submit comments online" button in the history section of the bill page.

Senator Holdcroft re-introduced <u>LB 124</u> which changes penalties for a motor vehicle homicide of an unborn child as a result of impaired driving. It enhances a Class IIIA felony to a Class IIA felony for first time offenders and Class IIA felony to a Class II felony for repeat offenders. Due to an oversight, Motor Vehicle Homicide (MVH) of an unborn child has a higher penalty classification than MVH DUI of an unborn child. The hearing for this bill took place on January 23rd.


LB 330 (Juarez) sets the sales tax on alcoholic liquor at 15.5%, a 10% increase. The revenue collected as a result of this 10% increase will be split between the Alcohol Addiction Prevention and Treatment Fund and the Education Future Fund. The bill has been referred to the Revenue Committee but not yet set for a hearing. Increasing the price of alcohol is an evidence-based strategy to prevent and reduce excessive alcohol consumption and the associated harms.

When they learned that an event did not have a liquor license as required by law, they shared information about the event with the Nebraska Liquor Control Commission and State Patrol.

Because of their tireless efforts, the event was postponed until the appropriate license was obtained. Jim and Cole continue to be advocates in their community and valuable members of the Project Extra Mile coalition.

He also prosecutes DUIs, Motor Vehicle Homicide, Underage Drinking, and other related



Going the Distance: Surgeon General Calls for Increased Awareness of the Alcohol & Cancer Link

On January 3rd, 2025, the U.S. Surgeon General Dr. Vivek Murthy <u>released a new advisory</u> on

alcohol and cancer risk. In this report he outlined the direct link between alcohol consumption at any level or intensity and the increased risk of at least seven types of cancer.

Dr. Murthy shared, "Alcohol is a well-established, preventable cause of cancer responsible for about 100,000 cases of cancer and 20,000 cancer deaths annually in the United States – greater than the 13,500 alcohol-associated traffic crash fatalities per year in the U.S. – yet the majority of Americans are unaware of this risk." As a result, he's wants to increase awareness to help minimize cancer diagnoses and deaths by updating health warning labels on alcoholic beverages to include a cancer warning and revising the U.S. Dietary Guidelines to account for cancer risk.
